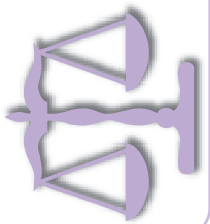

**From 495 Beltway:** North to Connecticut Avenue (Rt. 195) to Viers Mill Road (Rt. 586), left on Viers Mill and then an immediate left at light onto Ferrara Drive, which deadends into Holiday Park Multiservice Senior Center.

**From Rockville:** Follow Viers Mill Road. Ferrara Drive is the first light after Randolph Road (before Connecticut Avenue). Turn right onto Ferrara Drive, which deadends into Holiday Park Multiservice Senior Center.
